Reservation Terms and Conditions - Accommodation: page 2

This contract is personal and non-transferable.

- Our mobile homes are rented by the week, from 4.00 pm Saturday to 10.00 am Saturday.

- The accommodation sleeps 4 - 6 people, depending on the model chosen. If the total number of people in the party exceeds the sleeping capacity of the accommodation, you must provide your own tent, to be placed on the mobile home pitch, and charged at the standard camping tarif.

- On arrival you must provide a 200€ deposit (including cleaning fee) which will be refunded at the end of your stay (or at the latest by post one week after your departure). If the rental and its immediate surroundings are made in a state of immaculate (defrosted fridge etc.. /...) and if any abnormality or failure is found in the state of departure.

- On arrival the tenant is responsible for checking the inventory and inform the reception before

12 pm the next day of or failure anomalies found, after this time limit will be liable for costs

incurred : (inventory encrypted euros will be provided upon confirmation of your rental contract).

Electric barbecues are prohibited

ATTENTION : it is strictly forbidden to use the beds without bed linen.

- we do not provide bed linen

THE ACCOMMODATION DOES NOT INCLUDE BLANKETS / DUVETS / PILLOWS - YOU NEED TO BRING YOUR OWN.

- Clients in rented accommodation agree to respect the campsite rules (posted at the campsite entrance).

- VISITORS are authorised under the responsibility of their host. All visitors are obliged to present themselves at the campsite reception, and to pay the current daily visitor charge.

- In the event of cancellation, the deposit and booking fee are forfeit.

- You are obliged to pay the full amount due for the booking, even if you arrive late or leave early.

- If you fail to contact us regarding a delayed arrival we reserve the right to re-let the accommodation from the following day, and your deposit and booking fee will be forfeit.

- The price includes all charges apart from the local tourist tax (taxe de séjour) payable per person over the age of 13 years old.

ANIMALS : it should never be left alone in the rental or on the pitch.

Only one animal is accepted per accommodation. (Very large animals are not allowed inside the accommodation). Under no circumstances must animals be allowed on the seating or beds. There is a supplement of 2€ per night for your animal. (We do not accept dogs classified as 'dangerous breeds' under the Dangerous Dogs Act).
